THA TO RENOVATE 456 AFFORDABLE HOUSING APARTMENTS

Tacoma Housing Authority (THA) has secured \$36 million in private financing to renovate 456 of its affordable apartments. They are in nine properties throughout Tacoma. It does this using HUD’s Rental Assistance Demonstration Program (RAD). As part of this financing, THA exchanges its public housing funding for Section 8 funding. This will ensure its continued affordability. This project helps THA to keep providing high-quality housing to people in need with properties that are attractive assets for their neighborhoods.

BENEFITS OF PROJECT:

- **Renovations:** updated apartments including energy-efficient plumbing and lighting, improved security; as needed, new flooring, painting, carpets and countertops, building exteriors, elevator upgrades, and play areas.
- **Financial Sustainability:** keeps financially sustainable.
- **Energy reduction:** energy and water savings (low-flow toilets, sink aerators, low-flow shower heads, LED lighting and exhaust upgrades.)
- **Jobs:** 12 new jobs for THA residents and low-income Tacoma residents.
