This resolution would authorize Tacoma Housing Authority's (THA) Executive Director to negotiate and, if those negotiations are successful, execute a contract for environmental remediation construction services for 602 Wright Street and 911 North K Street and establish a NTE budget of \$319,000.

Background

On February 5, 2019, staff solicited bids for an environmental remediation contractor to provide construction services to install vapor mitigation systems at 602 Wright and 911 North K Streets required by the Department of Ecology. Staff posted the Invitation to Bid (ITB) and related addenda to Washington Electronic Business Solutions (WEBS) and THA's website. Proposals were initially due February 25, 2019; however, we did not receive any bids. In order to solicit bids, staff amended the proposal due date twice; first to March 4 and then to March 12.

On March 12, 2019, staff received one (1) bid from a qualified contractor in the amount of \$264,500. The bidder is Cascade Radon, Inc.

THA staff reviewed the bid according to the evaluation criteria listed in the ITB. Staff completed its review and determined that Cascade Radon, Inc. submitted a reasonable and responsible bid and is qualified to perform the contract. Cascade Radon demonstrated a qualified team of professionals dedicated to achieve the project budget and timeline. Staff determined the bid amount to be reasonable based on the cost analysis projected by our environmental consultant.

THA funds will pay the cost of the contract.

Staff recommends Cascade Radon, Inc. to provide the construction services to install vapor mitigation systems at 602 Wright and 911 North K Streets required by the Department of Ecology.
