RE:	HVAC for Maintenance and Repair to Holaday Parks, Inc.

Background

This resolution will authorize the executive director to negotiate, and if those negotiations are successful, to executive a contract with Holaday Parks for routine heating, ventilation and air conditioning (HVAC) maintenance and repair on all THA properties.

On May 22, 2015, Tacoma Housing Authority (THA) staff issued a Request for Proposal (RFP) for these services. With the assistance of BCE Engineers as THA's consultant developing the specifications, we meant this procurement to seek more extensive work including quarterly routine maintenance.

The proposals were due on June 16, 2015. THA received four (4) proposals. On June 22, 2015, the evaluation committee met and reviewed all four (4) proposals. The evaluation committee determined that Holaday Parks' proposal was the top proposal based on price and other factors. It should be noted that Holaday Parks also had the previous contract. The scoring of the RFPs received is as follows:
