RE: Salishan Division 3, Habitat for Humanity Lot Purchase & Sale Agreements

**Background**

The Salishan Revitalization Plan set-aside 25% of the homeownership lots for affordability. Salishan Area III is programmed for one hundred eighty two (182) homeownership lots of which (46) will meet the 25% threshold. Habitat for Humanity is interested in purchasing thirteen (13) affordable lots at the current appraised total value of \$749,411.

As an incentive to purchase these lots in 2010, THA will provide a discount of \$135,000 on the purchase. Authority for this discount is pursuant to RCW 35.82.070(5), which permits Seller to sell property to a nonprofit corporation at less than fair market value if the nonprofit corporation agrees to sell the property to a low-income person or family. Please see the attached schedule which identifies the legal address, gross purchase price, the credit discount, and the net purchase price of each lot.

Habitat expects to close on two (2) lots in June, and the remainder by the end of 2010. At this time staff is requesting the approval to execute the Purchase and Sale Agreement with Habitat for Humanity for the sale of thirteen (13) Salishan Division 3 affordable lots


